1.3 Intended use

The HistoCore CHROMAX ST Automated Slide Stainer is an IVD (in-vitro diagnostics) instrument.

The HistoCore CHROMAX ST Automated Slide Stainer is a stainer for laboratory applications and intended for the preparation of histological tissue samples. This product is used for staining of cells, tissue samples, etc. before pathological analysis.

1.4 Qualification of personnel

The HistoCore CHROMAX ST Automated Slide Stainer must be operated by trained laboratory personnel only. The instrument is intended for professional use only.

2. Safety

2.1 Safety notes





4. Setting up the Instrument

4.1 Installation site requirements

- Required hard surface: 1.16 x 0.67 m²
- The laboratory bench must be of sufficient bearing capacity relating to the instrument and must have a rigid surface.
- The device is intended for indoor use only.
- The next power socket must not be further away than the length of the power cord (2.5 m). Use of an extension cord is not allowed.
- The instrument needs to be connected to a grounded power supply socket.
- Use only the provided power cord intended for the local power supply.
- The instrument must not be installed below any air conditioning system.
- Any shaking, direct sunlight and significant current fluctuations need to be avoided.
- Proper function is ensured only if a minimum distance of 10 cm is respected towards all walls and any other fixtures.
- The instrument needs to be installed in a way that allows easy access to the power switch and the power plug at the rear side.
- Operation is not allowed in any areas exposed to explosion hazards.
- The installation site needs to be protected against electrostatic discharges.
- The installation site needs to be well ventilated because chemicals used within the instrument are highly flammable and unhealthy.
- Connect the instrument to a laboratory air exhaust system using the dedicated hose (lengths of 2 m and 4 m available). Alternatively the instrument can be operated below a fume cupboard. This should be run in addition to the active carbon filter.
- Please consider that the active carbon filter supports only filtration of hazardous vapors (Xylene).
- The situation at the installation site may vary significantly and depends on existing ventilation, emissions of other installed devices, the use of solvents, the volume of the room, etc.
- It is the responsibility of the laboratory owner/laboratory operator to not exceed the legal maximum permissible values and to take all measures at the working places regarding the solvent vapors. This includes also corresponding documentation.
- The operator of the instrument needs to make sure that sufficient ventilation is ensured and the active carbon filter is replaced within the required interval.
- The voltage selector and other internal components are preset by the manufacturer to meet the power requirements of the respective countries of destination.

Connecting to the external exhaust system

Connect one end of the exhaust air hose to the exhaust port (\rightarrow Fig. 2-15) at the rear side of the instrument. Connect the other end to an exhaust air device installed in the lab.


4.6 Oven

Put the paraffin tray on the oven floor.

4.7 Battery backup – UPS (optional)

An interruption of the staining process can be avoided in the event of a temporary power failure by connecting an uninterruptible power supply (UPS).

A compact UPS can be connected easily as shown below (\rightarrow Fig. 6) via the power supply jumper cable.



The UPS should be designed for an output of 650 VA for a duration of 10 minutes. However, the UPS will not maintain operation of the oven.

The UPS must be designed for power supply voltage at the installation location. Your distributor will gladly recommend a UPS that is suitable for you.

4.8 Remote alarm (optional)

The optional remote alarm is an interlock relay that is voltage-isolated from the rest of the instrument. When there is an alarm condition (a major operational malfunction or a power failure during a staining run with a UPS connected), the alarm circuit closes and the alarm sounds.



Note

• If you need a remote alarm that sounds even if there is a power failure, you have to use a batteryoperated remote alarm.

Ensure that the instrument is still turned on and confirm the message to turn off sound of the alarm. If the power fails during a staining run, you may first need to turn the Stand-by switch on the front side to Off and then back to On.



4.9 Switching on/off

LED strip

- LED flashing in white light: staining paused.
- LED in red light: the instrument has an error.

Switching off

1. When there is no program running, press the shut-down button on the touch screen. The following screen appears.



- 2. Confirm with OK.
- 3. Press the switch on the front side to Off position. The On/Off switch on the rear side of the instrument should be left On.

Restart after long time shut-down

If no longer uses the instrument due to maintenance or disposal, the user must first switch off the power supply and then remove the power cable, ensuring that it is stored correctly. In addition, the user must clean the instrument surface, and empty the reagent containers and wash containers. If an exhaust hose is fitted, it must be removed.





5.2 User management

This menu can be used to create and edit the user accounts.

5.2.1 Access levels

There are three access levels, Operator, Supervisor and Admin.

During the operation, the enabled buttons are highlighted and the disabled buttons are grayed out.

Operator

Operators can use the completely configured instrument for all routine applications, such as viewing/ selecting program, running/pausing/aborting staining, changing reagent, viewing running information. Operators can not modify programs and settings.

Supervisor

Supervisors have the same access options as the operators, and more access options, such as changing the bath layout, reagent management, program management, and instrument settings.

Admin

The admin account is configured at the factory. The Admin has the same access options as the supervisors, and more access options, that are user management and locking/unlocking the touch screen.

5.2.2 Initial log-in

The Admin account and its password are configured at the factory, which can be used to create new accounts. The default password is Admin1234. The password can be changed after the initial log-in.

To change the Admin's password, proceed as follows.

- 1. Press the Users tab.
- 2. Select the default account and press the Edit button.
- 3. Using the keyboard, enter Admin1234, then enter the new password twice and confirm with Save.

5.2.3 Adding/Editing/Deleting a user account

The account name cannot duplicate an existing user name or contain the word "Leica". The length of the user name shall be shorter than 30 characters. The password shall have at least 6 characters mixed with numbers and English letters.

Adding a user account

- 1. Press the Users tab.
- 2. Press New.
- 3. Enter the user name and the password. Choose an access level from the drop-down list.
- 4. Press Save.

Editing a user account

- 1. Press the Users tab.
- 2. Select a user account from the table and press Edit.
- 3. Change the user name and the password. Choose an access level from the drop-down list.
- 4. Press Save.

Deleting a user account

- 1. Press the Users tab.
- 2. Select a user account from the table and press Delete.
- 3. Press **OK** in the prompted confirmation dialog box.

5.2.4 Logout

1. Press the user-name icon



2. Select Switch user or Logout, and proceed with the next action of choice.

5.2.5 Locking/Unlocking the screen

The Admin can lock/unlock the touch screen. When the touch screen is locked, the system displays the last screen before locking. The unlock window will pop up when a user click the locked touch screen.



5.3 Settings

Press the **Settings** tab to open the **Settings** menu. Basic instrument and software settings can be configured in this menu.

Time

All user levels have the access.

Press the edit button (\rightarrow Fig. 13-11) in the line and modify the hour and minute. The date cannot be modified.

Language

All user levels have the access.

The default interface language (\rightarrow Fig. 13-2) is Chinese. Toggle to select between Chinese and English.

Fan

All user levels have the access.

Press the two ends to turn on or turn off the exhaust fan (\rightarrow Fig. 13-3).

When the oven is set to be **On**, the exhaust fan will be automatically turned on, even though it might be set to be **Off**.

Oven

Supervisor and Admin have the access.

Press the two ends to turn on or turn off the oven (\rightarrow Fig. 13-4).

When the oven is set to be On, enter the temperature between 30 °C to 65 °C and confirm with **OK**. The actual oven temperature value is shown on the **Status** screen (\rightarrow Fig. 9-3). The system turns off the oven automatically when actual oven temperature is abnormal, and an error message pops up for the oven failure.

Alarm volume

Supervisor and Admin have the access.

Set the volume (\rightarrow Fig. 13-5) from weak to strong, ranging from 2 to 9, and confirm with **OK**.

Loading time per holder

Supervisor and Admin have the access.

Set the loading time (\rightarrow Fig. 13-6) from 2 to 4 seconds and confirm with **OK**.

Unloading time per holder

Supervisor and Admin have the access.

Set the unloading time (\rightarrow Fig. 13-7) from 4 to 9 seconds and confirm with **OK**.

Up/Down movements (dips)

Supervisor and Admin have the access.

Press the two ends to turn on or turn off the Up/Down movements (\rightarrow Fig. 13-8). When the Up/Down movements are set to be On, fill in the continuous times (from 1 to 20 times) and the duration of an entire dip (from 1 to 4 seconds) (\rightarrow Fig. 13-9).

The time for one complete movement up and down (dip) is set in the adding a new program (\rightarrow p. 39 – Adding a new program).

If the staining time for a selected number is too short, only the number of dips that fit into the specified staining time will be done.

5.3.2 Slide counting report

Slides in each rack to be stained are counted by the system (\rightarrow p. 44 – 5.6.5 Loading racks). Press **Slide counting** tab to view the latest 3 years slides counting number by day or by month.

Press **Export** button to export the slide counting report.

5.3.3 Reagent exchange report

Press Reagent exchange tab to view the latest 3 years reagent exchange information by month.

Press Export button to export the reagent exchange report.

5.3.4 User run log report

Press Run log tab to view the intermediate and completion status of protocols by day, for the last 3 years.

5.3.5 Service

Press **Service** tab to view the versions of the installed software and the firmware and the instrument serial number.

To export the log, press Log file.


The Leica-authorized service staff can access to more functions for diagnostics and repairs to the HistoCore CHROMAX ST.

5.4 RMS (Reagent Management System)

Press the RMS tab to open the RMS menu.

5.4.1 Reagent information

Press Reagent information to view reagent information.



The reagent information includes: Reagent color (\rightarrow Fig. 14-1), Station number (\rightarrow Fig. 14-2), Reagent name (\rightarrow Fig. 14-3), Max days (\rightarrow Fig. 14-4), Max slides (\rightarrow Fig. 14-5), Stained days (\rightarrow Fig. 14-6), Stained slides (\rightarrow Fig. 14-7), Exchange date (\rightarrow Fig. 14-8), Exchanger (\rightarrow Fig. 14-9).

The Stained days and Stained slides are displayed in red color (\rightarrow Fig. 14-10) if the reagent in this station expired.

The field for max days or max slides is displayed as N/A (\rightarrow Fig. 14-11) if the Max days or Max slides are not set.

5.4.2 Station management

Press Station management to configure stations.



The system is configured with the pre-installed bath layout. It is for Leica pre-installed program. Admins can change the bath layout.

The three reagent stations next to the load drawer can be set as the inner buffer stations. The inner buffer stations can be used to store three racks ready for staining. The inner buffer stations must be continuous, which means there cannot be non-inner buffer station between two inner buffers or between the inner buffer and the load drawer.

The two washing stations, W1 and W2, can be set as reagent stations. The Oven station and W3/W4/W5 washing stations cannot be changed.

The reagent expiry reminder can be set by days and/or by slides on this screen. The reagent expiry reminder warns you that the replacement of a reagent is necessary. When it is enabled, the expiry status flag (\rightarrow Fig. 10-5) appears on the bath layout if a reagent expires soon or expired.

To change the bath layout and/or set the reagent expiry reminder, proceed as below.

- 1. Select the station.
- 2. Click the Reagent station icon (\rightarrow Fig. 15-1). The reagent list screen appears.
- 3. Select a reagent and press Select.
- 4. Set the reagent expiry thresholds and reminders. The reagent expiry thresholds are maximum days and/or maximum slides. The reagent expiry reminders are remaining days and/or remaining slides.
- 5. Save the change to the select station.

5.4.3 Reagent management

Press Reagent management to configure the reagent list.

There are pre-installed reagents in the system. The pre-installed reagents are used in Leica pre-installed program, including:

- Staining reagents: HemaLast, Hematoxylin, Eosin
- Differentiator, Bluing Agent, Orange G, EA50
- Ethanol: 100% Ethanol, 95% Ethanol, 90% Ethanol, 85% Ethanol, 80% Ethanol, 75% Ethanol, 70% Ethanol
- Xylene: Xylene, Xylene free
- Other: Ammonia, 1% alcohol hydrochloride, distilled water, water, saturated lithium carbonate, 0.5% alcohol hydrochloride

The pre-installed reagents cannot be deleted or edited.

User-defined reagents can be added to the reagent list.

To add a new reagent, proceed as below.

The HistoCore CHROMAX ST has one pre-installed program (\rightarrow p. 49 – 5.10 Pre-installed program), and can store up to 99 user-defined programs. By default, the programs fall into four categories: H&E staining, Cytology staining, Special staining and Others.





A program icon includes:

- Program name (\rightarrow Fig. 18-1)
- Total steps number of a program (\rightarrow Fig. 18-2)
- Label "L" for Leica pre-installed programs (\rightarrow Fig. 18-3)

- Numbered yellow flag for favorite programs (\rightarrow Fig. 18-4). The default program is labelled with a star icon.
- Red icon indicates that the program is not valid.

Overview of program steps

A program contains up to 25 steps. A step consists of the following information:

- the step number
- the station
- the reagent
- the staining time (min./sec.), ranging from 0 min. 0 sec. to 99 min. 59 sec.
- · Whether the staining time is to be achieved exactly or not

The step number defines the order in which the stations are used. The staining time is the time the rack is fully immersed in a station.

Times may overlap when multiple racks are being processed simultaneously, therefore the steps requiring precise adherence to the specified dwell time are designated as exact in the program. Therefore, staining times at these steps have priority and are adhered to with an accuracy of ± 1 second. Racks that are in a step that was designated not exact are processed further as soon as the transport arm is available for that.

5.5.1 Leica staining programs (pre-installed)

- Leica staining programs are preinstalled at the factory and have had their function and staining properties tested. They ensure consistent staining quality for a specified number of slides.
- · Leica staining programs are labeled with a letter "L".
- The individual program steps of the Leica staining program cannot be edited or deleted.

5.5.2 User-defined staining programs

- · Leica does not provide testing nor a warranty for user-defined programs.
- The testing of these staining programs using the respectively used reagents and adjusted temperatures must be carried out in the lab by the user. To do so, the staining result has to be checked with a specimen cycle (trial sections) before the program is used for patient specimens for clinical diagnostics.

5.5.3 Adding/Viewing/Editing/Copying/Deleting a program

Assign incompatible reagents to adjacent stations.

Adding a new program

- 1. Press the Programs tab, then press New button.
- 2. Select one program group and confirm with **OK**.
- 3. Enter a program name and confirm with **OK**. The program name cannot duplicate the preinstalled program name or contain the word "Leica". The length of the program name shall be shorter than 50 characters.
- 4. Select the station (\rightarrow Fig. 20-1), staining time (\rightarrow Fig. 20-2) and whether the staining time is exact or not (\rightarrow Fig. 20-3). Then confirm with **OK**.



- 5. Press Add button. Repeat step 4 until the program is complete.
- 6. Save the program.

• When the instrument is set as a workstation, the last step of the program must be set to the **EXIT** drawer.

Inserting a step into a program

- 1. Press the **Programs** tab, and select the program that is to be modified. Then press **Edit** button.
- 2. Select the step number where the new step is to be inserted, and press Insert.
- 3. Enter the steps details (\rightarrow Fig. 20) and confirm with **OK**.

- 4. Save the program.

Removing a step from a program

- 1. Press the **Programs** tab, and select the program that is to be modified. Then press **Edit** button.
- 2. Select the step number which is to be deleted. Press Delete and confirm with OK.
- \checkmark The selected steps are removed and the subsequent steps are renumbered.
- 3. Save the program.

Editing a program name

- 1. Press the **Programs** tab, and select the program that is to be modified. Then press **Edit** button.

- 3. Edit the program name using the keyboard and confirm with OK.

Saving a program

When the program is complete, save it as follows:

- From the edit program screen (→ Fig. 19), you now have the options of saving the edited program, leaving the program as it was before the changes were made, or continuing editing the program.
- 2. Press Save to save the program, or
- 3. Press Cancel to leave the program unchanged, or
- 4. Select steps and press New or Edit to continue editing the program.

Viewing a program

To view a program:

- 1. Press the **Programs** tab, and select the program that is to be viewed.
- 2. Press View.
- 3. Press Return to go back to the program list screen.

Copying a program

- 1. Press the **Programs** tab, and select the program that is to be copied.
- 2. Press Copy.
- 3. Enter the program name and confirm with OK. The program is listed in the same group of the copied program.
- 4. Press Edit, if you want to do further modification.

If the selected program is assigned to a rack currently being processed, copying is not allowed and a corresponding message appears on the touch screen.

Deleting a program

- 1. Press the **Programs** tab, and select the program that is to be deleted.
- 2. Press Delete and confirm with OK.

5.5.4 Setting favorite programs

Supervisor can set three favorite programs and set favorite program priority 1, 2, and 3. The favorite programs are labeled with yellow tags. On the **Status** screen, the favorite programs are displayed in order of priority 1, 2, and 3 (\rightarrow Fig. 9-10). The first favorite program is set as the default program by default.

The pre-installed program is set as the first favorite program in the factory.

To set a favorite program, proceed as below.

- 1. Press the Programs tab, and press Favorite.
- 2. Press one of the Favorite program fields.
- 3. Select a program from the program list.
- 4. Save the favorite program.

5.5.5 Checking the compatibility of programs

This function is used to check whether two programs can be run simultaneously. Programs cannot be run in parallel if they would need to control two identical stations defined as "exact" simultaneously, or if they contain two identical stations in reverse order, as in the following example:

Program 1	Program 2
Station 1	Station 1
Station 2	Station 2
Station 3	Station 3

However, the instrument carries out this calculation automatically.

The HistoCore CHROMAX ST has the loading capacity of 11 racks at a time with up to 30 slides each. It can accept a new rack as soon as the load drawer is empty and the **LOAD** key is lit up. Then the specimen slides are stained according to the program selected for the respective holders. Different programs may be used simultaneously, provided they are compatible. The method for checking compatibility is described on (\rightarrow p. 41 – 5.5.5 Checking the compatibility of programs).

5.6.1 Reagent containers

Reagent containers can be individually removed for filling. Each container holds up to 450 ml. The maximum and minimum filling levels are on the inside. When filling the reagent, make sure that the volume of the reagent is not either more than the max level or lower than the min level.

Water containers and reagent containers have different shapes and colors. Water containers are blue and reagent containers are white. After being filled, they are put in the instrument at the position designated in the corresponding programs.

The yellow reagent container is specified for the load drawer. Make sure that it is inserted into the load drawer with the handle folded on the right side.

To make the containers easier to identify, a label can be inscribed or attached on the side directly above where the handle is connected.

Warning

Label adhesive/ Labels on slide not solvent-resistant. Identification of the sample is no longer possible.

Damage of sample

- The stickers and/or labels used on the specimen slides must be resistant to the solvents used in the instrument.
- When printable labels or handwritten labels are used on the rack handles and the specimen slides, they must be checked for solvent resistance prior to use.

A schematic drawing of the individual stations is inside the instrument on the back plate (\rightarrow Fig. 1-18). Make sure that the containers are inserted correctly and that all handles are folded to the correct side so that they do not obstruct transport of the racks. Lids are provided to reduce evaporation of solvent while the reagent containers are not in use. The containers of the LOAD and EXIT drawers can also be filled with a reagent, if desired. However, the instrument will not monitor the immersion times in these two stations.

Filling reagents

To fill the reagent, proceed as below.

- 1. Press the station icons. The Replace the reagent screen is displayed.
- 2. Check the exchanger name.
- 3. Press the station that is to be filled in. The stations to be filled are marked with ticks on the top right corner. Fill the reagent container outside of the instrument with the corresponding reagents and set it back in the correct position in the instrument. The reagent level must be below the maximum filling level mark.
- 4. Confirm filling by pressing the **Replace** button on the screen. The screen returns to the Replace the reagent screen. The background of the tick turns to green.
- 5. Repeat step 3 to 4 for stations that are to be filled.
- 6. Press Return button and go back to the Status screen.

5.6.3 Wash system

Before setting up the instrument every day, check the water inlet to the instrument and turn it on.

The wash system consists of five flow-through wash stations, each capable of holding one rack. Water is supplied through the opening in the container floor and drains through the cut-out at the upper left edge.

The floor of the station has a locating pin, which means the station can be used only in one direction. Be careful when removing or inserting wash containers, because using excessive force may damage the seals. Wet the O-ring before inserting the wash station.

To use the wash station, slowly open the water tap in the lab all the way.

If the flow rate drops below 8 liters/minute for any reason, the wash period specified in the program may have to be extended.

5.6.4 Water-saving function

The instrument has a water-saving function that stops the flow of water when none of the wash stations are in use and the reagent residue has been flushed out of them.

Racks are inserted into the instrument only via the load drawer, which is on the front right side of the instrument. Reach fingers into the recess on the underside of the drawer, release the lever by gently pushing it up and pull the drawer out as far as it will go. The yellow reagent container is specified for the load drawer, which is designed to ensure the proper loading of the rack. Insert the container into the load drawer with the handle folded on the left side. Load the rack in the load drawer with the colored handle facing you, so that the slides counting function and RMS can work properly. Failure to use in accordance with this regulation may result in harmful radiation exposure. Avoid direct eye exposure while the system is counting the slides. Non-professionals may not alter the laser supply voltage or current or perform other operations that will increase the output power without permission.

To load a rack:

- 1. Select the program in the favorite program list. Or press More... to select a program from the program menu.
- 2. Check to see whether the load drawer is actually empty (the **LOAD** LED will be lit). Open the drawer and insert the rack, ensuring that it is positioned correctly. Close the drawer.
- Press the LOAD key. If the program is compatible with the programs already in use, then the LOAD LED will turn off and the rack will be processed using the selected program, otherwise a message will appear in the display and the holder will not be processed.



Note

- The LOAD button LED on means that the system accepts loading a new rack. The LOAD button LED off means that the system does not accept loading a new rack.
- 4. To load additional racks, repeat step 2 to 3. If the instrument is in the midst of processing a rack, there may be a delay before processing of additional holders begins.

If the pre-defined program is to run, the system counts the slides in the racks before the staining program starts. The slide counting starts when the transport arm moves from the load drawer to R1 station. After the slide counting finishes, the transport arm moves back to the top of R1 station.

Use HistoCore CHROMAX ST racks to avoid wrong slide counting.

5.6.6 Viewing the running information during staining

Press the rack icon (\rightarrow Fig. 9-4) to view the running information of each rack during staining.

When a rack is in the EXIT station, the **EXIT** LED will be on and the ring will sound every 30 seconds.

To unload from the **EXIT** drawer:

- 1. Open the **EXIT** drawer carefully and remove the holder. Alternatively, you can remove the entire reagent container including the holder and replace it with another.
- 2. Close the drawer and press the **EXIT** key. Then the LED will go out.

Note

• If the **EXIT** key is not pressed, the instrument will be unable to finish processing other holders that require this station.

5.6.8 Unloading racks from other stations

- To abort staining of one or more racks.

To interrupt a staining run:

- 1. Press Pause in the Status screen.
- 2. To cancel processing of a holder, press the cancel icon on the rack icons, or edit programs not currently in use, or change the general instrument settings.
- 3. Press **Continue** to continue staining.

5.8 Aborting the processing of a rack

To abort the processing of a rack:

- 1. Press Pause in the Status screen. The LED strip flashes.
- 2. To cancel the processing of a rack, press the cancel icon on the rack icons.
- 3. Open the hood and carry out the rack as quickly as possible.
- 4. Close the hood and press **Continue** to continue staining.

6. Cleaning and Maintenance

Clean the interior stainless steel surfaces with a detergent and then rinse them with water. Clean the transport arm surfaces by wiping them with a damp cloth.

The transport arm contains sensitive electronic components, therefore do not use any liquid in this area. Wipe clean only.

The drainage system may be flushed with 5% sodium hypochlorite to inhibit bacterial growth. However, metal parts must not be in contact with this solution for prolonged periods (such as overnight). Flush well with water afterwards. Painted exterior surfaces can be cleaned with a mild detergent and then wiped with a damp cloth.

Do not use solvent on the outer surfaces, particularly the touch screen and the hood!

Carefully wipe the control panel with a damp cloth.

6.1 Wash containers

Remove the wash containers and clean them with detergent. Reagent and rinsing water containers can be cleaned in a dishwasher, at a maximum temperature of 65 °C, using a standard, commercially available detergent for lab dishwashers. The handles can remain attached to the various containers during this process.

6.2 Reagent containers

Clean with warm water and detergent.

6.3 Racks

Clean with household or laboratory detergent as needed.

6.4 Oven

Regularly check the paraffin tray on the oven floor and clean it if you find excessive paraffin residue.

Clean the oven when it is cool.

6.5 Water drainage

- · Check and clean the draining system regularly for correct flow.
 - 1. To clean the water draining system, remove the rinsing water containers and all surrounding reagent containers.
 - 2. The remaining reagent containers have to be covered with lids.
 - 3. Remove the drainage sieve and clean it if necessary.
 - 4. Place one to two cleaning tablets with active oxygen into the drain and dissolve in water to remove various residue (reagents, bacteria, fungi, algae).
 - 5. Then, clean the entire curved drainage area inside the instrument with a long, flexible brush.
 - 6. Check the flow by flushing thoroughly with water.
 - 7. Insert the drainage sieve again, and put the containers back in their original, defined positions.
 - 8. Remove any lids from containers before processing racks into them.

6.6 Cleaning and Maintenance Schedule

Note

• The instrument must be switched off before cleaning.

Daily

- Touch screen: clean with a lint-free cloth.
- Outside surface: clean with a soft cloth and mild detergent.
- Do not use any of the following for cleaning the outside surfaces of the instrument: xylene, acetone, solvents containing xylene or acetone, scouring powders, and cleaning fluids containing ethanol.

Weekly

- Wash containers: can be cleaned in the lab dish washer (not over 65 °C).
- Reagent containers: can be cleaned in the lab dish washer (not over 65 °C).
- Drain outlet/hose: check for dirt, algae; flush with 5% sodium chloride.
- · Paraffin collecting tray: check in the oven.
- Interior stainless steel: clean with detergent and rinse with water.
- Transport arm: with slightly moistened cloth.

Monthly

- · Glass cover for the slides counting sensor: clean with ethanol using a lint-free cloth gently
- Strainer(v-filter): check for dirt.
- Air vent holes of fan: vacuum clean.
- · Tap water inlet hose connection
- · Activated carbon filter: change every 3 months.
- Electrical connections

7. Troubleshooting

The HistoCore CHROMAX ST has a system that continually monitors the instrument's functions. It displays corresponding error messages if any errors occur. If a minor error occurs during staining, the instrument will first attempt to correct the problem on its own. If this is unsuccessful, then a message appears and the instrument waits for the user to rectify the problem.

Some errors trigger an audible alarm. This alarm can be turned off by confirming on the screen.

If there is an error message, press Pause to pause staining.

Error messages and their meanings are listed on the following pages.

7.1 Warning messages for instrument errors

Mains power fail	This warning indicates a power failure. It appears only if a UPS is connected.

Power supply fail	The power supply device has failed and must be repaired.

Oven overheating	If this message appears, it is very likely that the oven is blocked. Make sure the slot in the oven floor is not blocked.
Remove obstruction and replace rack on hook	The rack could have separated from the hook. Remedy the problem (e.g., the reagent container is inserted incorrectly) and put the holder back on the hook.

7.3 Power failures

The instrument restarts as soon as the power supply is restored.

During initialization, the instrument software issues a series of messages and instructions to you, which provide you with information about the power failure and instruct you regarding how to proceed.

You can cancel or resume the staining process software using the displayed assistance.

If the power supply is not restored for a long time:

- 1. Press the Stand-by switch at the front panel of the device to shift to the Off mode.
- 2. Remove the rack hooked on the transport arm/tilted on the reagent container immediately to avoid reagents contamination.
- 3. Move the transport arm to sideways (for example, the right end position beside the LOAD drawer).
- 4. You should decide if you want to continue all processing racks manually according to the duration of power failure.
